- Collection of original documents from customers, banks, airlines or shipping companies;
- Monitoring of parameterization until due Customs Clearance and, when necessary, physical checking of all cargo; NF-e mirror.

- Normal and Simplified;
- Conference of Commercial Invoice and packing list;
- Preparation, monitoring and obtaining of Certificate of Origin;
- Coordination in cargo removal, container stuffing and reception at the shipment destination;
- Issuance of bills of lading (AWB or BL);
- Monitoring of parameterization until due Customs clearance and when necessary, we physically check all cargo;
- Monitoring until the cargo arrives at its final destination.
